

Seeq End User License Agreement

- **Important – Please Read This Agreement!**
- This Agreement is a binding legal document between Seeq and your company, which explains your company's rights and obligations as a Customer using Seeq products.
- By installing or using any Seeq products, you agree on behalf of Customer to be bound by this Agreement. If you do not agree to this Agreement, then do not install or use Seeq products.
- In particular, in areas of conflict, this Agreement shall take precedence over Customer Order Documents (as defined below).
- A separate license agreement that has been signed by Customer and Seeq shall take precedence over this Agreement.
- From time to time, Seeq may modify this Agreement, including any referenced policies and other documents. Any modified version will be effective at the time it is posted to Seeq's website at <https://www.seeq.com/end-user-license-agreement/>. To keep abreast of your license rights and relevant restrictions, please bookmark this Agreement and read it periodically. By using any Product after any modifications, Customer agrees to all of the modifications.

This End User License Agreement ("**Agreement**") is entered into by and between Seeq Corporation, 600 1st Ave., Suite 330, PMB 78762, Seattle, WA 98104, USA ("**Seeq**") and the legal entity or company executing an Order Document ("**Customer**"). Seeq and Customer agree as follows.

1) Definitions.

"Affiliate" or "Affiliates" means any company, corporation, partnership, joint venture, or other entity in which any of the Parties directly or indirectly owns, is owned by, or is under common ownership with a Party to this Agreement to the extent of at least fifty percent (50%) of its equity, voting rights or other ownership interest (or such lesser percentage which is the maximum allowed to be owned by a foreign corporation in a particular jurisdiction).

"Customer Data" means data in Customer's data resources that is accessed by, and processed in, Seeq software. Customer Data includes all Derived Data, as well as Customer's inputs provided to AI Products (defined in Section 4).

"Customer Personnel" means Customer's employees and contractors working on behalf of customer and does not include customers or clients of Customer.

"Derived Data" means data derived by Customer Personnel from Customer Data and consists of scalars, signals, conditions, journals, analyses, analysis results, worksheets, workbooks and topics.

"Documentation" means Seeq's standard specifications, installation materials, training materials, and online help documents normally made available by Seeq in connection with the Software, excluding marketing materials, as modified from time to time by Seeq.

"Order Document" means each ordering document signed by Seeq and Customer from time to time for the purchase of licenses for the Software. Customer's Purchase Order is not an Order Document. All Order Documents are incorporated by reference into this Agreement.

"Personal Data" means any information related to an identified or identifiable natural person; an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

"SaaS Software" means Software that is installed on hardware arranged by and under the control of Seeq on Microsoft Azure or AWS. SaaS Software is managed by Seeq. All Seeq SaaS Software relies on "**Agents and Connectors**" that are installed on hardware owned or arranged by and under the control of Customer, such as Customer-owned hardware or Customer's private or public cloud. Agents and Connectors are managed by Customer.

"Seeq Technology" means the Software, the Documentation, all algorithms and techniques for use with the Software created by Seeq, and all modifications, improvements, enhancements and derivative works thereof created by Seeq.

"Software" means the Seeq software applications identified on an applicable Order Document that are licensed to Customer

pursuant to this Agreement.

“Subscription License” means a license under Section 2 below for Software for the period of the Subscription Term.

“Subscription Term” means the period of time specified in an Order Document during which the Subscription License is in effect.

2) Subscription License.

- a) License. Seeq grants Customer a non-exclusive, non-transferable, non-sublicenseable right to access and use SaaS Software and to copy, install, and use Agents and Connectors for the duration of the Subscription Term, subject to the terms and conditions of this Agreement.
- b) Order Documents; Affiliate Use. Customer (or an Affiliate) and Seeq (or an Affiliate) may enter into Order Documents for Subscriptions. Each Order Document is a separate contract between the Customer entity and the Seeq entity specifically named in the Order Document. The rights, obligations, and liability under an Order Document extend only to those entities named in that Order Document. Seeq is under no obligation to offer the same or similar commercial terms to Affiliates.
- c) Excess Use of Software. Only Customer Personnel may use the Software, and only subject to all limits and metrics specified in the applicable Order Document. Customer designates in the Software each individual authorized to use the Software. If Customer uses the Software beyond any limit or metric specified in the applicable Order Document, Customer will purchase additional license rights or immediately cease all such excess use. Seeq may monitor Customer’s use of the Software.
- d) Subscription Term. The Subscription Term shall begin and end as provided in the applicable Order Document. The Subscription Term will not renew, except by a new Order Document signed by Seeq and Customer. This Agreement will continue in effect for the Subscription Term of all Order Documents hereunder.
- e) Merger & Acquisition (“M&A Activity”) by Customer. If Customer’s M&A Activity results in increased usage of the Software, including without limitation beyond limits indicated in the applicable Order Document, Customer must enter into a new Order Document for the increased usage.
- f) Divestiture by Customer. If Customer divests an entity or part thereof (“Divested Entity”) during the then-current Subscription Term, Customer may allow Divested Entity to continue to use its instance, subject to the terms of applicable Order Document, through the earlier of i) the expiration of the then-current Subscription Term as indicated in Customer’s current Order Document or ii) one (1) year from the date the divestiture is complete. If Divested Entity requires a separate instance, Divested Entity must enter into its own Order Document, subject to Seeq’s then-current rates, under the terms of this Master License Agreement or a separate license agreement with Seeq. Seeq shall offer commercially reasonable transition services, which may include additional fees on a time and materials basis, payable by Customer or its Divested Entity.
- g) Limitations on Use. All use of Software must be in accordance with the relevant Documentation. Customer will use the Software for its internal business purposes only and to process information about the operations of Customer and its Affiliates, and will not, except as provided in an Order Document, directly or indirectly, use the Software to process information about or for any third party. Customer will: (i) not permit unauthorized use of the Software, (ii) not infringe or violate the intellectual property rights, privacy, or any other rights of any third party or any applicable law, (iii) ensure that each Software user uses a unique ID and password, (iv) not, except as provided in an Order Document, allow resale, timesharing, rental, or use of the Software in a service bureau or as a provider of outsourced services, (v) not modify, adapt, create derivative works of, reverse engineer, decompile, or disassemble the Software or Seeq Technology, and (vi) not allow any Customer Personnel to gain or attempt to gain unauthorized access to the Software or any other Seeq system or website through use of another person’s credentials or by any other means. If Customer has subscribed to the Software for Virtual Operations Center (VOC) use, Customer may use the Software to analyze data of its clients but may not allow its clients to use the Software.
- h) Software Modification. Seeq may modify the Software from time to time, but such modification will not materially reduce the functionality of the Software.

- 3) **Support.** Seeq will provide support for the Software, including applicable updates and upgrades, as specified in an Order Document. Additional professional Services may be purchased from Seeq or a Seeq Partner at additional charge. Seeq SaaS Software will be provided with the service levels specified in Seeq’s Service Level Agreement, as in effect from time to time, available at <https://www.seeq.com/seeq-saas-service-level-agreement/>. Seeq may contract with third parties to support the Software, so long as they are subject to obligations of confidentiality to Seeq at least as strict as Seeq’s to Customer. Seeq shall remain responsible for the performance of its contractors.

4) Ownership.

- a) Customer Data. Customer owns all Customer Data, including all Derived Data, and Seeq shall not receive any ownership

interest in it. Seeq may use the Customer Data only to provide the Software capabilities purchased by Customer and as permitted by this Agreement, and not for any other purpose. Customer is the owner and data controller for the Customer Data. If requested by Customer, the parties will negotiate a mutually agreeable Data Protection Agreement.

- b) **Software and Seeq Technology.** Seeq retains all rights in the Software and the Seeq Technology (subject to the license granted to Customer). All new Seeq Technology developed by Seeq while working with Customer, including any that was originally based on feedback, suggestions, requests or comments from Customer, shall be Seeq's sole property, and Customer shall have the right to use any such new Seeq Technology only in connection with licensed use of the Software.
- c) **Seeq AI Assistant and Premium AI.** Seeq AI Assistant and Premium AI ("AI Products") are tools leveraging artificial intelligence and are incorporated into and useable throughout Seeq Software. AI Products are optional, can be deactivated by Customer Administrators, and are primarily for assisting users in improving their use of the Software. The AI Products do not utilize Customer Data to train their technologies or models. Seeq has both automated and manual quality assurance of all aspects of our AI Products that check for product safety, quality and latency; however, it is possible for this technology to provide incorrect answers, including Seeq Formula functions that may not exist. It is the responsibility of the Customer to confirm the accuracy of the outputs from AI Products.
- d) **Third-Party Open Source Software.** The Software incorporates third-party open source software. All such software must comply with Seeq's Third Party Open Source License Policy, which prohibits use of "copy-left" software.

5) Fees and Payment Terms.

- a) **Fees.** Customer shall pay the fees as specified in the Order Document. Unless otherwise specified in the Order Document, all amounts are in US Dollars (USD).
- b) **Invoicing & Payment.** All payments are due within thirty (30) days of the date of the invoice and are non-cancellable and non-refundable except as provided in this Agreement. If Customer does not pay any amount (not disputed in good faith with required notice to Seeq) when due, Seeq may charge interest on the unpaid amount at the rate of one-percent (1.5%) per month (or the maximum rate allowed by law, if less). Customer must provide notice of any disputed invoice to Seeq at ar@seeq.com within fifteen (15) days of invoice receipt. If an entire invoice or any portion thereof is disputed as provided herein and later resolved, Customer will remit payment by (i) the original due date, or (ii) ten (10) days after resolution of the dispute if resolved after the original due date. If Customer does not pay an overdue amount (not disputed in good faith) within 20 days of notice of non-payment, Seeq may suspend the Software until such payment is received, but Customer will remain obligated to make all payments due under this Agreement. Customer agrees to pay Seeq's expenses, including reasonable attorney and collection fees, incurred in collecting amounts not subject to a good faith dispute.
- c) **Taxes.** All fees are exclusive of all taxes, including federal, state and local use, sales, property, value-added, ad valorem and similar taxes related to this transaction, however designated (except taxes based on Seeq's net income). Unless Customer presents valid evidence of exemption, Customer agrees to pay any and all such taxes that it is obligated by law to pay. Customer will pay Seeq's invoices for such taxes whenever Seeq is required to collect such taxes from Customer.
- d) **Purchase through Reseller.** Solely in the event that Customer purchased its subscription to Seeq through a Seeq Reseller, then, except as provided in this subsection, the terms and conditions of this Agreement will apply to Customer's use of and access to the Software.
 - i) **"Reseller"** means an accredited Seeq Partner authorized to resell licenses for Seeq Software.
 - ii) **"Order Document"** means each ordering document for Customer's use of the Software submitted to Seeq by Reseller and accepted by Seeq from time to time for the purchase of licenses for the Software. No ordering document between Reseller and Customer is an Order Document for the purposes of this Agreement.
 - iii) **Fees and Payment Terms.** Sections 5(a) and 5(b) shall not apply to Customer, and the fees and payment terms in any agreement between Reseller and Customer shall apply as between them.
 - iv) **Non-Payment –** Under Section 12(a) below, non-payment by Customer to Reseller or by Reseller to Seeq shall constitute a material breach of this Agreement.
 - v) **Warranties.** Customer acknowledges that Reseller does not have the right to make any additional representations, commitments, or warranties binding on Seeq.
 - vi) **Precedence.** In the event of any conflict between the terms of this Agreement and any terms agreed to between Reseller and Customer, the terms of this Agreement shall take precedence and govern. Customer acknowledges that Reseller does not have the right to make modifications to this Agreement.

- 6) **Confidentiality.** "Confidential Information" means all information and materials obtained by a party (the "Recipient") from the other party (the "Disclosing Party"), whether in tangible form, written or oral, that is identified as confidential or would reasonably be understood to be confidential given the nature of the information and circumstances of disclosure, including without limitation Customer Data, the Software, Seeq Technology, and the terms and pricing set out in this Agreement and Order Documents. Confidential Information does not include information that (a) is already known to the Recipient

prior to its disclosure by the Disclosing Party; (b) is or becomes generally known through no wrongful act of the Recipient; (c) is independently developed by the Recipient without use of or reference to the Disclosing Party's Confidential Information; or (d) is received from a third party without restriction and without a breach of an obligation of confidentiality. The Recipient shall not disclose any Confidential Information without the Disclosing Party's prior written permission, except to its employees, contractors, directors, representatives or consultants who have a need to know in connection with this Agreement or Recipient's business generally, or as otherwise allowed herein. The Recipient shall protect the confidentiality of the Disclosing Party's Confidential Information in the same manner that it protects the confidentiality of its own confidential information of a similar nature, but using not less than a reasonable degree of care. The Recipient may disclose Confidential Information to the extent that it is required to be disclosed pursuant to a statutory or regulatory provision or court order, provided that the Recipient provides prior notice of such disclosure to the Disclosing Party, unless such notice is prohibited by law, rule, regulation or court order, and otherwise cooperates with the Disclosing Party to minimize any such disclosure. As long as an Order Document is active under this Agreement and for two (2) years thereafter, and at all times while Customer Data is in Seeq's possession, the confidentiality provisions of this Section shall remain in effect.

7) Security.

- a) **SaaS Software.** Seeq will maintain and enforce commercially reasonable physical and logical security methods and procedures to protect Customer Data on the SaaS Software and to secure and defend the SaaS Software against unauthorized access. Seeq will test its systems for potential security vulnerabilities at least annually. Seeq will use commercially reasonable efforts to remedy any breach of security or unauthorized access. Seeq reserves the right to temporarily suspend Customer's access to Seeq Software in the event of a suspected or actual security breach resulting from Customer's use of SaaS Software. Seeq shall not be liable for any damages incurred by Customer or any third party in connection with any unauthorized access resulting from the actions of Customer or its representatives.
- b) **Access Control.** Customer will maintain and enforce commercially reasonable security methods and procedures to prevent misuse of the log-in information of Customer Personnel. Seeq shall not be liable for any damages incurred by Customer or any third party in connection with any unauthorized access resulting from the actions of Customer or its representatives.

8) Beta Software. Seeq may offer Customer opportunities to use "Beta Software" (also referred to as Lighthouse Programs) meaning any software so-labeled by Seeq. Use of Beta Software is governed by this Agreement, except as specified below.

- a) Beta Software is experimental, may contain defects, and is not at the level of performance of a commercially available product offering. Seeq shall have no obligation to correct any defects or to further develop Beta Software. Seeq may modify or withdraw Beta Software at any time. Beta Software is not covered by the Seeq Service Level Agreement.
- b) Seeq may work with Customer to assist in the use and improvement of the Beta Software, but Seeq has no obligation to provide support or updates for Beta Software.
- c) Seeq or Customer may terminate the license for Beta Software at any time by notice, and Customer will immediately cease using or accessing the affected Beta Software and destroy any copies in its possession.
- d) THE BETA SOFTWARE IS PROVIDED "AS IS" WITHOUT ANY EXPRESS OR IMPLIED WARRANTY OF ANY KIND INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE. IN NO EVENT SHALL SEEQ OR ITS SUPPLIERS BE LIABLE FOR ANY DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF PROFITS, BUSINESS INTERRUPTION, LOSS OF INFORMATION) ARISING OUT OF THE USE OF OR INABILITY TO USE THE SOFTWARE, EVEN IF SEEQ HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- e) Section 11 shall not apply to claims arising from Customer's use of Beta Software.

9) Warranties.

- a) **Authority and Compliance with Laws.** Each party warrants and represents that it has all requisite legal authority to enter into this Agreement and that it shall comply with all laws applicable to its performance hereunder including export laws and laws pertaining to the collection and use of personal data.
- b) **Industry Standards and Documentation.** Seeq warrants and represents that the Software will materially conform to the specifications as set forth in the applicable Documentation. At no additional cost to Customer, and as Customer's sole and exclusive remedy for nonconformity of the Software with this limited warranty, Seeq will use commercially reasonable efforts to correct any such nonconformity, provided Customer promptly notifies Seeq in writing outlining the specific details upon discovery, and if such efforts are unsuccessful, then Customer may terminate the applicable Order Document and receive a refund of all pre-paid and unused fees for the affected Software. This limited warranty shall be void if the failure of the Software to conform is caused by (i) the use or operation of the Software with an application or in an environment other than as set forth in the Documentation, or (ii) modifications to the Software that were not made by Seeq or Seeq's authorized representatives.
- c) **Malicious Code.** Seeq will not introduce any time bomb, virus or other harmful or malicious code designed to disrupt the

use of the Software, other than Seeq's ability to disable access to the Software in the event of termination or suspension as permitted hereunder.

- d) **DISCLAIMER.** EXCEPT AS EXPRESSLY SET FORTH HEREIN, NEITHER PARTY MAKES ANY REPRESENTATIONS OR WARRANTIES OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT. EXCEPT AS STATED IN THIS SECTION, SEEQ DOES NOT REPRESENT THAT CUSTOMER'S USE OF THE SOFTWARE WILL BE SECURE, UNINTERRUPTED, OR ERROR FREE. NO STATEMENT OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED FROM SEEQ IN ANY MEANS OR FASHION SHALL CREATE ANY WARRANTY NOT EXPRESSLY AND EXPLICITLY SET FORTH IN THIS AGREEMENT.

- 10) Indemnification by Seeq.** Seeq shall indemnify, defend and hold Customer harmless from and against all losses (including reasonable attorney fees) arising out of any third-party suit or claim alleging that Customer's authorized use of the Software infringes any valid U.S. or European Union patent or trademark, trade secret, or other proprietary right of such third party. Customer shall: (i) give Seeq prompt written notice of such suit or claim, (ii) grant Seeq sole control of the defense or settlement of such suit or claim, and (iii) reasonably cooperate with Seeq, at Seeq's expense, in its defense or settlement of the suit or claim. To the extent that Seeq is prejudiced by Customer's failure to comply with the foregoing requirements, Seeq shall not be liable hereunder. Seeq may, at its option and expense, (i) replace the Software with compatible non-infringing Software, (ii) modify the Software so that it is non-infringing, (iii) procure the right for Customer to continue using the Software, or (iv) if the foregoing options are not reasonably available, terminate the applicable Order Document and refund Customer all prepaid fees for Software applicable to the remainder of the applicable Subscription Term. Seeq shall have no obligation to Customer with respect to any infringement claim against Customer if such claim existed prior to the effective date of the applicable Order Document or such claim is based upon (i) Customer's use of the Software in a manner not expressly authorized by this Agreement, (ii) the combination, operation, or use of the Software with third party material that was not provided by Seeq, if Customer's liability would have been avoided in the absence of such combination, use, or operation, or (iii) modifications to the Software other than as authorized in writing by Seeq. THIS SECTION SETS FORTH SEEQ'S ENTIRE LIABILITY TO CUSTOMER AND CUSTOMER'S EXCLUSIVE REMEDY WITH RESPECT TO ANY CLAIM OF INFRINGEMENT OF ANY INTELLECTUAL PROPERTY RIGHT.

- 11) LIMITATION OF LIABILITIES.** In no event shall either party or their service providers, licensors, contractors or suppliers be liable for any indirect, incidental, consequential, special or punitive damages of any kind, including without limitation damages for cover or loss of use, data, revenue or profits, even if such party has been advised of the possibility of such damages. The foregoing limitation of liability and exclusion of certain damages shall apply regardless of the success or effectiveness of other remedies. Except for the parties' indemnification obligations, damages for bodily injury or death, damages to real property or tangible personal property, and breaches of confidentiality under Section 6, and for Customer's usage and payment obligations under this Agreement, in no event shall the aggregate liability of a party, its service providers, licensors, contractors or suppliers arising under this agreement, whether in contract, tort or otherwise, exceed the total amount of fees paid or payable by Customer to Seeq for the relevant software within the twelve (12) months preceding the events giving rise to such damages.

12) Termination and Expiration.

- a) **Termination for Cause.** A party may terminate any Order Document: (i) for any material breach not cured within thirty (30) days following written notice of such breach, and (ii) immediately upon written notice if the other party files for bankruptcy, becomes the subject of any bankruptcy proceeding or becomes insolvent. Upon termination for cause by Customer under this Section, Seeq shall refund Customer all prepaid but unused fees representing the period from the date of Termination through the expiration date of the then-current Subscription Term. Upon termination for cause by Seeq under this Section, Customer shall promptly pay all unpaid fees due through the end of the Subscription Term of such Order Document.
- b) **Access and Data.** Upon expiration or termination of an Order Document, Seeq will disable access to the applicable SaaS Software, and Customer will uninstall and destroy all copies of Agents and Connectors and Documentation on hardware under its control, if any. Upon Customer request, Seeq will provide Customer with a copy of all Customer Data in Seeq's possession, in a mutually agreeable format within a mutually agreeable timeframe. Notwithstanding the foregoing: (i) Seeq may retain back-up copies of Personal Data associated with Customer's use of Seeq in its access logs for a limited period of time in accordance with Seeq's then-current access control policy, and (ii) Seeq will destroy all Customer Data no later than 3 months after end of the Subscription Term or earlier, upon written request from Customer.

13) General.

- a) **Amendment.** Seeq may modify this Agreement from time to time, including any referenced policies and other documents.

Any modified version will be effective at the time it is posted on Seeq's website at <https://www.seeq.com/end-user-license-agreement>.

- b) **Precedence.** The Order Document is governed by the terms of this Agreement and in the event of a conflict or discrepancy between the terms of an Order Document and the terms of this Agreement, this Agreement shall govern except as to the specific Software ordered, and the fees, currency, and payment terms for such orders for which the Order Document shall govern, as applicable. If an Order Document signed by Seeq explicitly states that it is intended to amend or modify a term of this Agreement, such Order Document shall govern over this Agreement solely as to the amendment or modification and solely with respect to the Subscription Term and Subscription License described in such Order Document. Seeq objects to and rejects any additional or different terms proposed by Customer, including those contained in Customer's purchase order, acceptance, vendor portal or website. Neither Seeq's acceptance of Customer's purchase order nor its failure to object elsewhere to any provisions of any subsequent document, website, communication, or act of Customer shall be deemed acceptance thereof or a waiver of any of the terms hereof.
- c) **Assignment.** Neither party may assign this Agreement, in whole or in part, without the prior written consent of the other, which shall not be unreasonably withheld. However, either party may assign this Agreement to any Affiliate, or to a person or entity into which it has merged or which has otherwise succeeded to all or substantially all of its business or assets to which this Agreement pertains, by purchase of stock, assets, merger, reorganization or otherwise, and which has assumed in writing or by operation of law its obligations under this Agreement, provided that the assignor (or assignee, if applicable) shall provide prompt notice to the non-assigning party once legally and contractually permitted to do so. The non-assigning party may terminate this Agreement if the intended assignee of this Agreement is a direct competitor of the non-assigning party, or an entity with which the other party is legally prohibited from doing business, provided that there shall be no refund of any pre-paid but unearned fees, and any remaining payments under an Order Document will remain payable. Any assignment or attempted assignment in breach of this Section shall be void. This Agreement shall be binding upon and shall inure to the benefit of the parties' respective successors and assigns.
- d) **Non-Solicitation.** To the extent legally permitted by applicable law, each party agrees that during, and for one year after, the term of this Agreement, it will not directly or indirectly solicit for hire any of the other party's employees who were actively engaged in the provision or use of the Software without the other party's express written consent. This restriction shall not apply to offers extended solely as a result of and in response to public advertising or similar general solicitations not specifically targeted at the other party's employees.
- e) **Independent Contractors.** The parties are independent contractors and not agents or partners of, or joint venturers with, the other party for any purpose. Neither party shall have any right, power, or authority to act or create any obligation, express or implied, on behalf of the other party.
- f) **Right to Publicity.** Customer agrees that Seeq may reference Customer's name and logo on its website and in other external marketing materials. For all other marketing collateral, Seeq shall (i) Customer an opportunity to review any external marketing materials or presentations in advance of publication; and (ii) remove any references at any time upon Customer's written request provided to marketing@seeq.com.
- g) **Notices.** All notices required under this Agreement shall be in writing to the applicable addresses below the signature block of this Agreement, and shall be effective if given by email and by copy to: (i) Seeq at legal@seeq.com and 600 1st Ave, Suite 330, PMB 78762, Seattle, WA 98104, Attn: Legal, and (ii) Customer at the then-current email and physical address in Seeq's records. Physical delivery shall be by either (x) personal delivery, (y) recognized international overnight courier, or (z) registered or certified mail return receipt requested. All notices shall be effective and shall be deemed delivered on the date of the later to occur of email or physical delivery if delivered before 5:00 p.m. local destination time on a business day, otherwise on the next business day after delivery. Either Party may change its notice address by notice to the other party.
- h) **Force Majeure.** Except for payment obligations hereunder, either party shall be excused from performance of non-monetary obligations under this Agreement for such period of time as such party is prevented from performing such obligations, in whole or in part, due to causes beyond its reasonable control, including but not limited to, delays caused by the other party, acts of God, war, terrorism, criminal activity, civil disturbance, court order or other government action, third party performance or non-performance, strikes or work stoppages, provided that such party gives prompt written notice to the other party of such event.
- i) **Integration.** This Agreement, including all Order Documents and documents attached hereto or incorporated herein by reference, constitutes the complete and exclusive statement of the parties' agreement and supersedes all proposals and prior agreements, oral or written, between the parties relating to the subject matter hereof.
- j) **Not Contingent.** The party's obligations hereunder are neither contingent on the delivery of any future functionality or features of the Software nor dependent on any oral or written public comments made by Seeq regarding future functionality or features of the Software.
- k) **No Third-Party Rights.** No right or cause of action for any third party is created by this Agreement or any transaction under

it.

- l) **Non-Waiver; Invalidity.** No waiver or modification of the provisions of this Agreement shall be effective unless in writing and signed by the party against whom it is to be enforced. If any provision of this Agreement is held invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not be affected or impaired thereby. A waiver of any provision, breach or default by either party or a party's delay exercising its rights shall not constitute a waiver of any other provision, breach or default.
- m) **Governing Law and Venue.** This Agreement will be interpreted and construed in accordance with the laws of the State of Delaware without regard to conflict of law principles, and both parties hereby consent to the exclusive jurisdiction and venue of courts in Wilmington, Delaware in all disputes arising out of or relating to this Agreement.
- n) **Dispute Resolution.** The parties agree to attempt to resolve disputes without extended and costly litigation. The parties will: (1) communicate any dispute to other party, orally and in writing; (2) respond in writing to any written dispute from other party within 15 days of receipt; (3) if satisfactory resolution does not occur within 45 days of initial written notification of the dispute, and if both parties do not mutually agree to a time extension, then either party may seek a remedy in court.
- o) **Survival.** Provisions of this Agreement that are intended to survive termination or expiration of this Agreement in order to achieve the fundamental purposes of this Agreement shall so survive, including without limitation: Ownership, Fees and Payment Terms, Confidentiality, Customer Data, Indemnification by Seeq and Limitation of Liabilities.
- p) **Headings and Language.** The headings of sections included in this Agreement are inserted for convenience only and are not intended to affect the meaning or interpretation of this Agreement. The parties to this Agreement and Order Document have requested that this Agreement and all related documentation be written in English.
- q) **Federal Government End Use Provisions.** Seeq provides the Software, including related technology, for ultimate federal government end use solely in accordance with the following: Government technical data and software rights related to the Software include only those rights customarily provided to the public as defined in this Agreement. This customary commercial license is provided in accordance with FAR 12.211 (Technical Data) and FAR 12.212 (Software) and, for Department of Defense transactions, DFAR 252.227-7015 (Technical Data – Commercial Items) and DFAR 227.7202-3 (Rights in Commercial Computer Software or Computer Software Documentation).
- r) **Contract for Services.** The parties intend this Agreement to be a contract for the provision of services and not a contract for the sale of goods. To the fullest extent permitted by law, the provisions of the Uniform Commercial Code (UCC), the Uniform Computer Information Transaction Act (UCITA), the United Nations Convention on Contracts for the International Sale of Goods, and any substantially similar legislation as may be enacted, shall not apply to this Agreement.
- s) **Actions Permitted.** Except for actions for nonpayment or breach of a party's proprietary rights, no action, regardless of form, arising out of or relating to the Agreement may be brought by either party more than one year after the cause of action has accrued.
